**OLD BUSINESS/FOLLOW UP**

- Jodi motion to approve September Minutes. Ryan seconded. Motion carried.

- Field Maintenance – Jodi would like to do something for Ted for all the hours he has put into painting all the fields. Ryan made a motion to give Ted a \$1000 VISA gift card. Adam seconded. Motion carried.
- Registration and rosters – This season has been a struggle as coaches are not getting registrations and rosters in on time. We are getting them after cutoffs and then it creates urgency on our part. We cannot continue to do this as there are deadlines that were given to the coaches and reminders sent. Coaches need to be held accountable.
- Stephanie said she creates a google doc at the beginning of the season to get availability for the tournaments.
  - Going forward, within the first two weeks of the season, the coach needs to send a google doc with the tournaments to get the availability for the season. This will hold parents and coaches accountable.
  - Asst Registrar to get list of tournaments put together.
  - The big topic at the coaches meeting needs to be tournament registrations and rosters
